#### 2019 STREET CATEGORY RULES REAL, MODERN AND SUPER STREET CLASSES

This category is intended for street-driven vehicles only. Cars, Street Rods, Pick-up Trucks and SUV vehicles in this category <u>MUST BE 100% STREET LEGAL</u>. ECTA officials will be the final authority as to vehicle eligibility.

In keeping with the intent of the class, all vehicles **must be licensed**, **registered (tagged) and insured** (**PROOF REQUIRED**).

#### **INTERIOR**

Must have driver and passenger seats

Must use a stock-appearing dash structure

#### May not have driver seat set back past stock location

- All street equipment must be retained and in working order. These items shall include but not limited to the following: functional windows, horn, working lights and directionals, alternator, radiator, (power steering and power brakes if installed must be operable)
- Full street legal interior minus rear seat. Firewall and floor pan must be steel and must be welded in.

MUFFLERS are required.

Fiberglass reproduction bodies are acceptable as long as the vehicle is street legal. It is highly recommended that you get pre-approval of non-OE fiberglass bodies.

# All vehicles in this category must complete a cruise through Blytheville. The cruise will be Saturday at 6 pm, it will be lead by ECTA officials

#### **ENGINE**

Engines must be based upon cylinder-block architecture offered by an OE manufacturer for use in production-line and or race vehicles. Altered bore spacing is prohibited. Deck height is open. <u>Billet</u> engine blocks and cylinder heads prohibited.

#### **DRIVER REQUIREMENTS**

Racers must possess a current government-issued valid driver's license. All drivers must sign a liability waiver and photo release during registration. If the driver is not the car owner, the driver must have all required documents, and must attest as stated in the waiver tht they have the car owner's permission to be in possession of and to race the vehicle. Racers must be at least 16 years of age to race. If racers re at least 16 years of age, but under 18 years of age, the racer and a custodial parent or legal guardian must sign all required waivers. The custodial parent or legal guardian must be in attendance with them during onsite tech, registration and all race activities.

## **CLASS SPECIFIC RULES**

#### REAL STREET – Class records are 3, 4, 6, 8, & 10 cylinder,

RS/3, RS/4, RS/5, GS/6, RS/8, RS/10

Real Street vehicles are limited to single 4-bbl carburetor or any combination originally offered and installed by the factory, not to exceed four one-barrel carburetors. No fuel injection and no supercharging. No items are allowed that would make any vehicle illegal for street use. No Nitrous Oxide or Straight Methanol

#### SUPER STREET – Class records are 4, 6, 8, & 10 cylinder, NA, Blown, nitrous and turbo. SS/4, SS/4N, SS/4B, SS/4BN, SS/4T, SS/4TN, SS/6, SS/6N, SS/6B, SS/6BN, SS/6T, SS/6TN, SS/8, SS/8N,

SS/4R, SS/4B, SS/4B, SS/4B, SS/4B, SS/4B, SS/4B, SS/8B, SS

**MODERN STREET - Class records are 4, 5, 6, 8, & 10 cylinder, NA, Blown, Nitrous and turbo.** MS/4, MS/4N, MS/4B, MS/4BN, MS/4T, MS/4TN, MS/5, MS/5N, MS/5B, MS/5BN, MS/5T, MS/5TN, MS/6, MS/6N, MS/6B, MS/6BN, MS/6T, MS/6TN, MS/8, MS/8N, MS/8B, MS/8BN, MS/8T, MS/8TN, MS/10, MS/10N, MS/10B, MS/10BN, MS/10T, MS/10TN.

Production cars 2004 and newer. Fuel Injection, Superchargers and Turbochargers allowed.Nitrous Oxide and water-methanol injection is allowed in this class. Nitromethane is NOT permitted. No items are allowed that would make any vehicle illegal for street use
